

## STATE LAND RECREATIONAL USE GROUP PERMIT

*Subject to terms and conditions*

### Arizona State Trust Land is not Public Land

A **'Recreational Use Permit'** is temporary and revocable and does not permit commercial, competitive or group events. Lands leased for agriculture, mining, commercial, or military purposes are not open to recreational use. Other State Trust lands may be closed to some or all recreational uses due to hazardous conditions, dust abatement, in coordination with the Arizona Game & Fish Department or based on certain State, County or Local laws or ordinances. Approximately 8 million acres of State Trust land are available for recreation, but access is not guaranteed. Please visit [www.land.az.gov](http://www.land.az.gov) for additional information.

A **'Group Permit'** authorizes limited access for less than 5 days, less than 20 people (listed below).

**'Non-Consumptive Recreation'** shall not devalue land by the removal of natural products from the land. Natural products include water, plants, trees, rock, boulders, sand and gravel.

Commercial, Competitive and Charitable events are consumptive and are not authorized by this permit.

### AIR QUALITY NOTICE

**In addition to current closures by the State Land Commissioner, many cities & counties now restrict the operation & parking of motorized vehicles on unsurfaced roads and vacant lots. Your State Land Recreational Use Group Permit requires you to obey all laws within the relevant jurisdiction. Check with the County and/or City Law enforcement to determine what rules apply.**

Permittee attests this to be the complete roster of all individuals to use State Trust land under this permit. Permittee also attests that each individual will read and agree to all of the terms and conditions prior to any activities taking place on State Trust land.

RECREATIONAL PERMIT TERMS AND CONDITIONS (You must initial your acceptance of the terms and conditions):

AUTHORIZATION

1. This permit is issued only for non-commercial, non-competitive, and non-consumptive recreational activities on State Trust land.

RESTRICTIONS

2. I will comply with all laws, rules, regulations, and ordinances; posting is not required for them to be enforceable.
  3. I will obey all lawful directives from law enforcement, State Land Department representatives, and public service announcements at <http://www.land.az.gov>
  4. This Permit does not include authorization to use any land other than State Trust land. I am responsible for obtaining any other permits necessary for my use.
  5. I will not collect or remove any natural products or cultural resources from State Trust land.
  6. I shall not visit any prehistoric, historic, or paleontological site(s) on State Trust land; nor remove or disturb any found artifacts.
  7. I will not frustrate or otherwise interfere with any commercial, mineral, agricultural, grazing or military leases.
  8. I will not harass livestock or wildlife; damage cultural or natural resources or vegetation; destroy or remove any improvements (e.g. windmills, earthen stocktanks, fences, corrals, wildlife water catchments, etc.).
  9. Motorized travel is restricted to existing roads and trails in areas/jurisdictions not otherwise closed to motorized use. **A one-time-use or single set of tracks does not constitute a road or trail.**
  10. Motorized recreation is not permitted within ¼ mile of any building or paved roadway; on and through stock tanks or watering holes; or within any area closed by ordinance or by order of the State Land Commissioner.
  11. I will not discharge firearms on State Trust land except for the lawful and licensed taking of game. Discharge of any air-gun, paintball gun or variants is prohibited on State Trust land.

RESPONSIBILITIES

12. I will leave gates either open or closed as they are found, or as signed. No fences will be cut or laid down.
  13. I will pack out my litter and refuse.
  14. Human waste shall be confined to portable toilet or a slit trench which will be covered to ground level upon closing camp. Waste from portable toilets shall be removed from site and disposed of properly.
  15. Recreational camping is limited to less than 5 days. A campsite must be at least ¼ mile from any livestock or wild-life water developments. Campsites are to be left clean.
  16. Campfires are to be thoroughly extinguished. I will comply with all fire restrictions and fire closure information issued by the Arizona State Forester.
  17. Permittee is responsible for notifying state lessees of group activities prior to entering land.

INDEMNITY

18. I shall indemnify and hold harmless the State of Arizona, its departments, and its employees from and against any and all claims, actions, liabilities, damages, losses, or expenses for bodily injury or personal injury (including death), or loss or damage to property, arising out of or related to the permitted recreational use of State Land. Use of State Land is accepted “as is”, without any warranty as to personal safety or hazards that may be present or particular to your use. By accepting these terms and conditions, I will use State Trust land at my own risk and peril.
